GREETINGS,

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said KINGSBURY PLANTATION, qualified to vote in Plantation affairs to meet at the Kingsbury Plantation Garage in Kingsbury Plantation, Maine on the 29th day of April A.D. 2023 at nine thirty o'clock in the morning to act on the following articles to wit:

ART. 1 To choose a Moderator to preside at said meeting.

ART. 2 To see what sum of money the Plantation will raise and appropriate for a Municipal Equalization Project of land and buildings and if approved by the Inhabitants of Kingsbury will allow the Assessors approval of the expenditures thereof and carry forward the balance at the end of the fiscal year.

ART.5 To see what sum of money the Plantation will authorize the Board of School

Directors to expend for the fiscal year July 1, 2023 to June 30, 2024 from Kingsbury Plantation's contribution to the total cost of funding Public Education from Kindergarten through Grade 12, as described in the Essential Programs and Services Funding Act, non-State funded school construction projects, additional local funds for school unexpected balances, tuition receipts, State Subsidy and other receipts for the support of schools.
